Purpose

Deringer is the largest privately-held U.S. Customs broker and one of the top five entry filers in the U.S. As a family-owned organization, Deringer offers agility and commitment to service excellence that every one of our employees embodies. We do not subscribe to a 'one size fits all' mentality – especially in this day of ever-changing government regulations, speedy data transmission demands, and custom reporting requirements. As with the Customs' business, transportation, distribution, and consulting, all lines of business focus on compliant, value-add services for a defined market niche.

Our reputation with U.S. Customs and Border Protection (CBP) and partner government agencies is unprecedented in the industry and a testament to our commitment to compliance. Deringer is extensively involved with leading industry organizations, serving on executive committees or the board of directors. We have also been appointed to serve on government committees and repeatedly asked to pilot new government initiatives.

We currently have over 500 supply chain professionals throughout more than 30 offices and distribution centers in the U.S. and remote employees in Canada. As a demonstration of our commitment to a high level of expertise and knowledge, we have 87 Licensed Customs Brokers, 44 Certified Customs Specialists, and 9 Certified Export Specialists. We believe we have the highest ratio of professionals with certifications to total employees in the industry.

Additionally, our internal shared services, such as Human Resources, Information Technology, Marketing, and Finance, employ colleagues with a substantial number certified in their respective fields. Our colleagues' commitment to service excellence and integrity is an important distinction within the industry, one that makes us extremely proud.
