Per [Proclamation 10908](#), certain auto parts (engines and engine parts, transmissions and powertrain parts, and electrical components) for passenger vehicles (sedans, sport utility vehicles, crossover utility vehicles, minivans, and cargo vans) or light trucks are subject to an additional duty. Goods eligible for a USMCA claim aside from automobile knock-down kits or parts compilations are not subject to the additional duty. Flagged HTSUS numbers that are not actually auto parts for passenger vehicles or light trucks are also not subject to the additional duties.

Per [Proclamation 10984](#), certain auto parts for medium or heavy-duty vehicles (Class III – Class VIII) are subject to an additional duty. Goods eligible for a USMCA claim aside from automobile knock-down kits or parts compilations are not subject to the additional duty. Flagged HTSUS numbers that are not actually auto parts for medium or heavy-duty vehicles are also not subject to these additional duties.
